RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

1. I agree to this RELEASE, WAIVER OF LIABILITY AND INDEMNITY AGREEMENT in consideration of being permitted to participate in any equestrian related activity associated with the Flying M Stables & Farm LLC, located on the premises at 3922 113th Ave SW, Olympia, WA. I further expressly agree that this release, waiver of liability and indemnity agreement is intended to be as broad and inclusive as is permitted by law in the State of Washington, and that if any part of this Agreement is held to be invalid, it is agreed and understood that the balance of the Agreement will continue in full legal force and effect.
2. By signing this Agreement, I represent and warrant that I accept the premises at 3922 113th Ave SW in Olympia, WA as reasonably suited for the purposes associated with this Agreement.

I further herby RELEASE, WAIVE, DISCHARGE AND PROMISE NOT TO SUE Flying M Stables & Farm LLC, and/or any of their members, employees, agents, participants or any entity or person connected with them during the activity, or any other person on the premises from any and all liability to the undersigned or my assigns, heirs and next of kin for any and all claims which may hereafter develop or accrue to me on account of, or by reason of, any injury, loss or damage which may be suffered by me and/or to my child, my ward or my invitee, or to my property because of any matter, thing or condition, negligence or default whatsoever, and I HEREBY ASSUME AND ACCEPT THE FULL RISK OF DANGER OF ANY HURT, INJURY OR DAMAGE WHICH MAY OCCUR REGARDLESS OF THE CAUSE.
4. I hereby expressly acknowledge and agree that ANY AND ALL ACTIVITIES ASSOCIATED WITH A HORSE OR HORSES ARE VERY DANGEROUS ACTIVITIES AND INVOLVE THE RISK OF SERIOUS BODILY INJURY AND/OR DEATH and/or property damage, and by signing this agreement, I do hereby expressly assume all risks.

I hereby agree to INDEMNIFY, SAVE, HOLD HARMLESS AND PROTECT the Flying M Stables & Farm LLC from any loss, liability, damage or costs incurred as a result of the participation of the undersigned in activities associated in any way at 3922 11i^h Ave SW, Olympia, WA, including reimbursement for any attorney's fees or costs incurred to defend any action or claim associated with my equine activity, regardless of whether such loss, liability, damage or costs are caused by any negligence of Flying M Stables & Farm LLC.
